TERMS AND CONDITIONS

- 1) **Purpose**: this agreement contains the entire agreement between the makeup artist and the client, it supersedes all prior and simultaneous agreements between the parties, the only way to add or change this agreement is to do so in writing, signed by all the parties or email correspondences.
- 2) **Reservation**: upon your signature or written email agreement, the makeup artist will reserve the time and date agreed upon to make you up for your wedding on that exact time and date, for this reason the reservation deposit is not refundable, even if the date is changed or wedding cancelled for any reason, including acts of God, fire, strike, and extreme weather. The reservation deposit is to be paid at the time of this contract/agreement. The wedding consultation is applied towards the contracted wedding package. Client understands and agrees that the total amount owed for the wedding package described in the contract is due as specified in the agreement, (40% booking fee, 60% balance fee two weeks before the wedding) client agrees if the balance is not paid before this time, the makeup artist will not make the client up on the wedding date specified on the contract, with a loss of reservation deposit by client and no liability to the makeup artist.
- 3) **Pre-event consultation**: The parties agree to pre-event colour testing and familiarization. This will be carried out on the premises of Beauty Cook Studio for clients within Lagos, as for out-of-state brides, the trial will take place on the day the makeup artist arrives at the destination. Location, colours and other specifications are agreed on that day. Please send a mail

In advance to book an appointment for this day to ensure availability of makeup artist.

- 4) **Bridal parties or extras:** only bookings made prior to the date will be attended to. In the case of extras e.g. sister, bridal train. Only cash payment will be accepted and will be charged to the bride directly. We will not collect money from individuals.
- 5) **Time frame:** we will require an average of 1 hour 30min to makeup the bride. We suggest you will be ready at the agreed time stated on your KNOWING THE BRIDES FORM. If for any reason under the makeup artist discretion, we are kept waiting. We begin to charge you per hour at the rate of 10,000 payable in cash.
- 6) **Working conditions and preferences:** in order to help us serve you best, and help you look your best. We suggest you prepare a well lite air conditioned room with as much inflow of natural light as possible, especially when choosing a hotel room. The makeup artist will not be held responsible if foundations and general makeup look don't turn out well in natural light. We will also prefer to work in a non crowed room, preferably the bride and chief bride's maid only per room.
- 7) **Transport and accommodation:** please note that all flight, accommodation and feeding fees are exclusive of the package price list. This will be charged to the customer's account after the entire process, where they are incurred.
- 8) All premium packages will be provided by Omontese Akhetuamen. However budget packages will be shot by our preferred in house makeup artist. They will maintain the beauty cook style as they do this
- 9) This document is provided by beauty cook studio for its members and clients stated and we will not be liable to either party for its use and enforcement.

10) Client may cancel a booking 6 months before the event. No surcharges will apply to deposited amount for cancelled bookings 5 months and below, a 10% surcharge be applied to the total amount agreed for the service, bookings cancelled 2 months before the event (for whatever reason) will forfeit the entire deposit made.

11) **Third party bookings**: client must liaise with beautycook at all times. We will not be held for misinformation from third party

12) We charge for skilled application. A client must make payment for whatever services a beauty cook makeup artist renders, even if she used the clients makeup items. We ensure our services are faultless and professional.

13) Photographs: beautycook reserves the right to use photographs of clients taken in our media publication, adverts, promotional items, studio e.t.c we do not owe you photographs taken. We shall release them to you on our own discretion.
